CAUTION - Vitamin B6 and peripheral neuropathy The Therapeutic Goods Administration (TGA) received a report of peripheral neuropathy from an individual taking a magnesium supplement, which also contained 4mg vitamin B6.

Review of the TGA database identified multiple reports of peripheral neuropathy for products containing doses of vitamin B6 below 50mg/day. In many cases, people were taking multiple products containing vitamin B6 that did not have a warning about this risk on the labels. At the time, only products with vitamin B6 daily doses over 50mg required a warning about peripheral neuropathy on the label.

The TGA asked for expert advice from the Advisory Committee on Complementary Medicines and conducted a public consultation on proposed regulatory changes. Subsequently, regulatory requirements were updated for listed medicines to strengthen label warnings and reduce the maximum permitted daily dose. The TGA also published a Medicines Safety Update for healthcare professionals and a Safety Alert for consumers.


The TGA continues to monitor reports of adverse events related to this issue, including whether the regulatory changes are sufficient to reduce the risk of peripheral neuropathy with vitamin B6.

## Reminder about casual employment changes

Casual employment rules changed on 26 August 2024. These changes include new pathways to permanent employment that start on 26 February 2025. Casual changes

From 26 February 2025, eligible casuals can provide written notice to their employer to change to full-time or part-time employment under the employee choice pathway. An employer can only refuse the notice for certain reasons.

## Other workplace changes

Other workplace changes taking effect from 26 February include:

- new model terms for enterprise agreements and other instruments

# **Do foil bag or not to foil bag, that is the question!** By

Whether 'tis nobler to use the foil bag to avoid the temperature excursions or . . . Putting William Shakespeare aside, what is the point of the foil bag?

# Do foil bags keep medicines cold?

The *National Vaccine Storage Guidelines* 'Strive for 5' state that 'foil bags commonly provided by pharmacists when vaccines are privately purchased are not effective in keeping vaccines at the correct temperature – for example, when the vaccine is left in a car or stored in a domestic refrigerator'. Suppliers of foil bags advise they are for transporting medicines that require short-term storage at a constant temperature until appropriate refrigeration can be reached.



They are not suitable for long-term storage.<sup>2</sup> It is unclear whether foil bags provide thermal protection and for how long.

Some pharmacists use foil bags to remind the patient that the medicine in the bag needs to go in the fridge.

However, the patient should still be advised to take the medicine straight home to put it in the fridge and not to rely on the false sense of security that the foil bag will keep it cold while they 'duck into the shops'

# What if the patient does not have a fridge?

Not all patients have consistent access to a fridge (e.g. travelling, power outages, no fixed address). It is useful to ask patients about this, and tailor your advice accordingly.

Cautionary Advisory Labels 6, 7a, 7b and 13 can supplement your verbal advice about storage where appropriate.<sup>3</sup>

For some medicines that require refrigeration, the approved Product Information (PI) contains guidance about room temperature storage options if refrigeration is unavailable or impractical.<sup>4</sup> You can also offer to store the medicine or not-inuse containers at the pharmacy until needed (e.g. pending a doctor's appointment, not-in-use insulin pens/cartridges).

# Opened containers – in or out of the fridge? It depends on the medicine.

The manufacturer has determined the stability and shelf-life of a medicine using the container and storage conditions outlined in the PI.

Keeping an in-use container in the fridge instead of at room temperature may extend its shelf-life. This might avoid wastage if the dose changes.

However, cold eye drops and injections can cause discomfort. They should generally be allowed to reach room temperature before they are administered.

In-use multi-dose injections or eye drops should be kept at room temperature unless otherwise advised by the PI.
